## Conditions of Marina Pen, Hardstand Cradle or Swing Mooring Rental

We the applicant(s) agree to be bound by the following terms, in conjunction with the HBYC constitution, rules and by-laws for the term of occupancy of a marina pen or handstand cradle.

1. All fees associated with Marina Pen, Hardstand Cradle & Swing Mooring rentals are payable on request in accordance with the schedule of fees. Owners who are un-financial may be asked to remove the vessel from the facility in accordance with the Constitution and Rules & By-Laws.
2. The owners agree and are responsible for maintaining current insurance, including \$10Million public liability. A copy of a current policy or a certificate of currency is required to be kept on file in the office.
3. It is the owners' responsibility to ensure the vessel is secure at all times.
4. It is the owners' responsibility to ensure the cradle operation, storage and vessel lifting equipment is maintained in safe working order.
5. This application is for a term of occupancy of 12 months and will be reviewed every 6 months. Previous terms of occupancy of marina pens, hardstand cradles and swing moorings does not guarantee renewal.
6. Pen allocations may vary from time to time to assist in marina utilisation.
7. Inactive vessels may be asked to leave the marina pen or hardstand cradle in accordance with the Marina Pen and Hardstand Cradle Allocation Policy and may be placed on a club mooring, if available.
8. Notwithstanding points 1-8, the club reserves the right to move any boat at anytime without the owner's consent to assist with the proper utilisation of the club's facilities.
