Conditions for Slipping Boats at Hobsons Bay Yacht Club

- No boat with a laden weight exceeding 10 tonnes will be slipped without the authority of the General Committee. Any boat deemed to be in excess of 10 tonnes will be required to present certification of weight.
- The completion of this slipping form provides for temporary membership of the HBYC for the purpose of slipping or berthing non-HBYC registered boats.
- All anticipated work to be performed must be listed on the slipping form prior to slipping.
- Best OH&S practices must be implemented at all times, including the Test & Tag of all electrical leads and tools.
- All contractors to perform work on your boat at HBYC must be listed an insurance details supplied before commencement of any work.
- Appropriate safety equipment must be worn and or used while working in the yard.
- All care must be taken to protect boats and vehicles in the vicinity of your boat.
- Covers must be used at all times (to protect boats and cars) while painting.
- All preparation work must be performed under covers to protect adjacent boats and cars.
- All dry sanding must have a working dust collection system attached.
- Work areas must be kept clean, tidy and free from tripping hazards at all times.
- Boat cradles must be able to be moved within the yard at all times. Cradles can only be moved by authorized persons (see yard manager).
- All ladders, scaffolding and trestles on site must comply with the OH&S guidelines.
- All hoses and electrical leads must be disconnected at the completion of the day.
- Please see yard staff regarding the disposal of hazardous waste. Do not dispose of hazardous waste via drains or household bins in the yard. Advice can be sought from your local council and Sustainability Victoria on 1800 353 233.
- Non-stretch rope and slings for slipping are to be supplied by the owner. Log removed if required.
- I hereby agree to conform to abide by all rules and conditions of the "Hobsons Bay Yacht Club Constitution and Rules".
- I hereby agree to conform to the By-Laws made pursuant to rule 1 to 18 (Slipping, Yard Storage and Cradles).
- I hereby agree to pay all slipping, yard and miscellaneous charges as per the HBYC Rule 26.
